#### **WELCOME VOTERS!**

The LWVMC is pleased to provide a *Voters' Guide* to help you prepare to vote in the General Election. Candidate responses to League questions, including any received after our print deadline, along with information about each of the ballot questions, are available at **VOTE411.org**. When you type in your home address at **VOTE411**, the website will automatically display the ballot question information and responses from the candidates who will appear on the ballot in your precinct.

A printed copy of the *Guide* is automatically mailed to new voters for the first election after they register. For future elections, go to the LWVMC website to choose whether you prefer a printed copy of the *Voters' Guide* or an email with the link to the candidate responses. Go to **lwvmocomd.org** and click on the VOTE drop-down menu. Select *Voters' Guides*. Follow the directions to choose to receive the *Guide* as a printed copy or email link.

## About the Voters' Guide and the League of Women Voters

This *Voters' Guide* is published by the League of Women Voters (LWV) of Montgomery County, MD, part of a nonpartisan organization of women and men promoting informed participation in government and does not support or oppose any political party or candidate.

The LWV developed explanations of the two ballot questions on your ballots. The League also sent issue questions to all candidates requesting responses before our print deadline. Their answers, presented exactly as written by the candidates, along with the ballot question information can be found in the following locations:

- This print version of the *Voters' Guide* includes candidate responses received before our print deadline.
- The LWV Montgomery County website, **lwvmocomd.org**, provides links to the PDF of the *Voters' Guide*.
- The Spanish edition of the *Guide*, which will be published as an insert in *El Tiempo Latino* on October 11, also will be posted on the LWV website **lwvmocomd.org**.
- **VOTE411.org** has all responses, in English and Spanish, as provided or approved by the candidates, including any responses received after our print deadline. It also includes the ballot question information in English and Spanish.

#### **About the 2024 General Election**

The General Election ballot includes the following:

- Nominees of the Democratic and Republican parties, chosen in their primaries
- Nominees of the other political parties recognized in Maryland (Libertarian, Green and No-Labels parties), chosen by their central committees
- Candidates who are not affiliated with a party or are affiliated with a party not recognized in Maryland. ("Other" party)
- State and county ballot questions

All registered voters, regardless of their political affiliation, may vote for any candidate on their ballot. Your ballot will list only candidates for your Congressional district. Your district is listed on your voter registration card or sample ballot. View your sample ballot online at **voterservices.elections.maryland.gov/VoterSearch**.

Maryland law allows a voter to write in a candidate's name for offices on the ballot. Write-in candidates who filed with the State Board of Elections are considered "qualified" and are listed at all in-person voting locations and at **elections.maryland.gov/elections/2024/ General\_candidates/index.html**. Write-in votes for any candidate who has not filed a certificate of candidacy and is not on the qualified write-in candidate list will be counted as part of the total votes cast and will be reported in the "other write-in" total.

#### **Voter Registration**

For information on eligibility to vote in Maryland and how to register to vote, scan the QR code below or visit the State Board of Elections website at **elections.maryland.gov** and click on the *Register to Vote* box.



#### SAME-DAY REGISTRATION

Citizens who are not registered to vote in Maryland may register for the first time and vote in person at an Early Voting Center during early voting OR at their local precinct on General Election Day, provided they bring identification. Click on Registration Process at **elections.maryland.gov/voter\_registration/index.html** for a list of documents accepted as proof of residency.

#### **Request a Mail-in Ballot**

Request a mail-in ballot in English or Spanish at **voterservices**. **elections.maryland.gov/OnlineMailinRequest/InstructionsStep1** OR call the Montgomery County Board of Elections at 240-777-8550 to have an application mailed or faxed to you. **The deadline to request a mail-in ballot be mailed to you is October 29; for internet delivery, the deadline is November 1.** 

Voters may remove themselves from the permanent mail-in ballot list by using the Voter Registration Update form at https://voterservices.elections.maryland.gov/onlinevoterupdate/InstructionsStep1. The change will be effective for the next election.

#### **Ways To Vote**

There are three ways to vote in the Maryland General Election:

#### 1. EARLY VOTING — In-Person Voting

Voters may choose to vote at any of the 14 Early Voting Centers, which are open from **7 am to 8 pm, Thursday, October 24 through Thursday, October 31**. Ballots from all precincts will be available at each of the Montgomery County Early Voting Centers. The list of Centers is available at **montgomerycountymd.gov/elections/earlyvoting/earlyvotingcenters.html**. You may also text EV and your zip code to 77788.

#### 2. ELECTION DAY — In-Person Voting

On General Election Day, **Tuesday, November 5**, voters should go to their assigned polling places. Polls are open from **7 am to 8 pm**.

Your sample ballot lists the name and address of your precinct polling place right above your name on the address label. You can also look up your polling place at **voterservices.elections. maryland.gov/VoterSearch**.

**Note:** Early Voting Centers are closed on Election Day, unless serving as a local precinct polling place. On General Election Day, any voter who votes at a location other than the voter's assigned precinct will be required to use a provisional ballot, which may not correspond to candidates for the district where the voter lives.

#### CELL PHONE USE IS NOT PERMITTED IN POLLING PLACES

You may bring any printed material such as a paper sample ballot and the Voters' Guide with you when you vote. You are NOT permitted to use electronic devices such as smartphones, tablets and computers inside polling places—even while you are in line.

#### 3. MAIL-IN BALLOT

Your mail-in ballot will include instructions on how to complete and return it. Using the envelope provided, you can:

- Mail your ballot as soon as you have completed it. It must be postmarked on or before November 5 and received by the Board of Elections by 10 am on November 25, 2024.
- Take your ballot to a Montgomery County ballot drop box. Your ballot will include a list of the drop box locations. A list of locations is also posted at montgomerycountymd.gov/ Elections/dropbox.html or you can text BOX and your zip code to 77788.
- Hand deliver your ballot. You may deliver it to the Montgomery County Board of Elections (18753 N. Frederick Ave, Suite 210, Gaithersburg, MD 20879) or to your precinct polling place before 8:00 pm on November 5. During early voting (October 24-31) you may deliver it to an Early Voting Center.

#### **Mail-In Ballot Tracking**

Check the status of your mail-in ballot request or whether your voted ballot was received at **elections.maryland.gov** and click on the Track your Ballot box.

**Caution:** if you requested a mail-in ballot but decided to vote in person, you will be required to vote a provisional ballot.

## **On the Ballot**President of the United States

(see Candidates on pages 6-7)

#### **Duties**

The President is the head of state of the United States of America, the Chief Executive Officer and the Commander in Chief of all military forces. The powers of the President are prescribed in the Constitution and federal law. The President appoints the members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court justices and federal judges, subject to Senate approval. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to the Congress.

#### **How Elected**

Voters in every state cast ballots for President. The President is not elected directly by the voters. Instead, our votes for candidates are used to select "Electors" who meet in an "Electoral College" to choose the President. For more information, visit www.archives.gov/electoral-college/about.

#### Term

Four years. Limit of two terms.

#### Salary

Presidential salary: \$400,000 per year.

## Criteria for participation by U.S. Presidential candidates in VOTE411.org and this *Guide*:

Four of the five presidential candidates on Maryland's ballot met the following League of Women Voters Education Fund (LWVEF) criteria: (1) The candidate must have made a public announcement of her/his intention to run for her/his Party's nomination for President; and (2) The candidate must meet the Presidential Election Campaign Fund Act's minimum contribution threshold requirements for qualifying for matching funds, based on the most recent data publicly available on the Federal Elections Commission website.

We need an economy that works for working people, not just the wealthy and powerful. To reverse surging inequality and insecurity, we need an Economic Bill of Rights establishing the rights to a living-wage job, guaranteed livable income, housing, healthcare, childcare, lifelong education, secure retirement, utilities, healthy food and clean water, so that all of us are guaranteed the basic security for a good life that can reach our highest potential. Healthcare is a human right. We need a universal healthcare system that is equitable, comprehensive, free at point of service, and accessible to every single person in the US.

A Jill Stein administration will immediately implement National Improved Medicare for All as a precursor to establishing a UK-style National Healthcare Service which will replace private hospital, private medical practice, and private medical insurance with a publicly-owned, democratically controlled healthcare service that will guarantee healthcare as a human right to everyone in the United States. We will take the pharmaceutical industry into public ownership to provide medicines as a public good. We will also codify Roe v. Wade and advance reproductive rights.

We need to end the epidemic of gun violence with common-sense gun safety laws. A Jill Stein administration will ban the sale of assault rifles and establish a buyback program; establish mandatory waiting periods and background checks for firearm purchases; pass red flag laws for individuals who pose a danger to themselves and others; create standardized digital records of gun registrations and sales; close gun show loopholes; require firearm owners to own a high-quality gun safe to store their firearms; require firearm owners to purchase liability insurance of no less than \$1,000,000; and hold adult firearm owners criminally liable for minor children accessing and using firearms in the commission of any crime, accidental injury or

Immigrants' rights are human rights. It's time to completely overhaul the broken and abusive immigration system, as well as the unjust policies driving people to leave their homes. We need a comprehensive immigration policy and properly funded institutions to ensure a timely, ethical, transparent, and dignified path to citizenship for immigrants, asylum seekers, and refugees. Border policy should move away from detention and enforcement response toward humane and effective asylum processing. A Jill Stein administration will replace ICE with an Office of Citizenship, Refugees, and Immigration Services under the Department of Labor, grant amnesty to every undocumented person, and implement a path to citizenship with expediency.

We all have a human right to a livable planet with a stable climate, healthy food, clean air and water, and living soil. We need a real Green New Deal to transition rapidly from an economic system that is destroying our only home to a sustainable society built around human needs and protecting life on Earth.Our Green New Deal will invest in renewable energy, a publicly-owned nationwide smart energy grid, clean transportation technology, energy efficiency and conservation to generate millions of good-paying jobs, rapidly phase out fossil fuels and achieve 100% clean renewable energy and zero-to-negative carbon emissions by no later than 2035. We need to act now so that our children and future generations can not only survive, but thrive.

#### **Duties**

U.S. Senators make laws along with the members of the U.S. House of Representatives, ratify treaties and conduct investigations on issues of national importance. The Senate confirms presidential appointments, including Supreme Court justices.

#### **How Elected**

Elected statewide. In 2024, Maryland voters will elect one of our two Senators. About one-third of the 100 members of the Senate is elected every two years.

#### **Term**

Six years. No term limit.

#### **Salary**

\$174,000 per year.

#### **Angela Alsobrooks**

**D** - Democratic angelaalsobrooks.com

I am proud to have spent my life in public service, first as an Assistant State's Attorney focused on domestic violence cases, then as State's Attorney, where under my tenure violent crime dropped by 50%, and most recently as Prince George's County Executive. I know Marylanders deserve a Senator who both fights for them and shares their concerns. I am running for Senate to be a voice for families like the ones I grew up with and whom I have worked for throughout my life.

I will fight to eliminate the filibuster and pass critical legislation like the John Lewis Voting Rights Act and Freedom to Vote Act. I'm proud to be endorsed by Congressman John Sarbanes and End Citizens United // Let America Vote, two leading voices for protecting voting rights, strengthening election laws and taking money out of politics.

Urgent action is needed to address the climate crisis. I will be a vocal advocate for the Green New Deal, as well as for expanding tax credits for clean energy and ensuring that all U.S. Government purchases, from buildings to vehicles, align with emission goals. As County Executive, I issued an Executive Order for Prince George's County, setting ambitious targets to reduce the 2005 emission levels by half before 2030 and net zero by 2045. I believe the U.S. should adopt a similar timeline

I will be a strong advocate for comprehensive immigration reform to mend the broken immigration system, including creating a pathway to citizenship for those already living and working in the United States. I will support initiatives such as the American Dream and Promise Act, aimed at safeguarding the rights and future of DREAMers and TPS recipients. I firmly believe these individuals deserve certainty and security, regardless of who holds the office of the President.

As a mother, I have been deeply affected by the tragic loss of too many children to gun violence and am frustrated by the lack of action from Washington. I am committed to fighting for essential gun safety legislation to protect children and communities from gun violence. I will work to implement universal background checks and red flag laws, close the gun show loophole, ban military-style weapons like AR-15s, and prohibit devices like bump stocks.

#### **Larry Hogan**

**R** - Republican larryhogan.com

Governor Hogan has a long record of solving hard problems and overcoming broken politics—including working with the state's Democratic legislature to cut taxes, lower health care costs, and make generational investments in universal broadband and workforce development; leading the nation's governors through the worst global pandemic in more than a century; and, as co-chair of No Labels, partnering with the Problem Solvers Caucus to advance a historic federal infrastructure bill.

Free and fair elections are the foundation of American democracy and the most basic promise that those in power can pledge to citizens. Governor Hogan supports state and local efforts to ensure safe and secure elections by combating election interference and intimidation. He also looks forward to continuing to work with the League of Women Voters and other leading civic-minded organizations on initiatives to end partisan gerrymandering and restore fairness in the electoral system.

While Washington was failing to address climate change, Maryland was leading under Governor Hogan—enacting cleaner air standards stronger than 48 other states and far stronger than the Paris Agreement. In addition to supporting strong environmental stewardship and sustainability, he believes it is especially critical to bring both state and federal resources to bear in holding upstream polluters accountable and protecting regional Chesapeake Bay cleanup goals.

The humanitarian and security crisis at our southern border underscores the need to fix our broken and badly outdated immigration system. One party alone didn't cause these problems, and one party alone cannot solve them. Governor Hogan will work with any leader willing to set politics aside and work on real solutions—starting with securing the border and addressing the flow of migrants.

Governor Hogan believes it is possible to respect the rights of law-abiding gun owners while making it harder for criminals and the mentally ill to obtain firearms. In addition to red flag legislation, the governor has long called for federal action to institute a federal universal background check system. He also strongly supports providing law enforcement with more tools and resources to protect our communities—including increasing penalties for those who commit a crime with a gun.

#### **Mike Scott**

**L** - Libertarian mikescott2024.com

I am a long range planner and strategist. I have almost 30 years of combined federal service in the defense, acquisitions, communications, and ethics communities. I've built and managed multi-billion dollar budgets. I have trained and led people. I received a TOP SECRET clearance in 1994. I've forgotten more about federal service than my opponents will ever know. Most important point-I'm not a politician. I will do the work that needs to be done in Senate.

Election Day should be a 2-3 day event. It should be done in person. Early voting should be left to military and absentee voters. We should move away from voting machines that can be hacked. But, the BIG thing: we need term limits and campaign finance reform. That takes away the impetus to cheat in elections. We need money out of politics and there are ways to do it.

When COVID hit, one of the unintended consequences was the Earth got to BREATHE again. I suggest investment in viable, ATTRACTIVE public transportation. We have too many cars and trucks on the road. The use of Nuclear power (the reactors that re-use, not store waste) would also help. I'd encourage investment in Hemp plastics and construction materials. But, to fix pollution & the environment? PEOPLE have to CARE.

The problem with immigration is America's rampant welfare state, and our fractured domestic and foreign policy. We destabilized the middle east (GWOT & Israel policies), destabilized Latin America (Drug War), now we're messing about in Africa (Sudan, Congo) and Europe (Ukraine). In other words, we have a LOT to fix to fix immigration. I'd like an Ellis Island style immigration system to quickly process immigrants. And, eliminate monetary incentives to come to America and NOT work.

I'm unreasonably pro 2A. The Constitution was not meant to give citizen's rights. It was designed to limit government's power to deny rights. They banned fully automatic weapons, in part, because Blacks were protecting our neighborhoods with them. Weapons are not only necessary for self defense, they put a check on government power. With all the corruption and graft in government, I can't IMAGINE what they'd do to us if we disarm. And, both parties want us disarmed.

#### **Duties**

U.S. Representatives make laws along with the members of the U.S. Senate and conduct investigations on issues of national importance. Laws that impose taxes always begin in the House of Representatives. Representatives can recommend that the Senate remove from office a public official accused of a crime.

#### **How Elected**

Elected by voters in each Congressional District. Maryland has eight of the 435 congressional districts, based on the state's population in the 2020 Census. Montgomery County residents are represented by three Congressional Districts: 4, 6 and 8.

#### **Term**

Two years. No term limit.

#### Salary

\$174,000 per year

## On the Ballot Judge of the Circuit Court – Sixth Circuit

#### **Duties**

Judges preside over trials in the Circuit Court, which is a court that hears major civil cases and serious criminal cases, such as those requiring a jury trial. Circuit Courts may decide appeals from the District Court and certain administrative agencies. The Sixth Circuit Court serves Montgomery County.

#### **How Elected**

Elected countywide. The state is divided into eight Judicial Circuits. When there is a vacancy, a nominating commission reviews the qualifications of applicants for the judgeship and recommends several names to the Governor, who appoints a person from that list to fill the office. Each newly appointed judge must run for office at the first election that occurs at least one year after the vacancy occurred. Sitting judges must also run for re-election after serving for 15 years. Attorneys who are members of the Maryland Bar may also run to challenge a newly appointed or sitting judge.

#### **Term**

Fifteen years. No term limit. Mandatory retirement age of 70 years.

\$204,433 per year.

Before becoming a judge, I prosecuted murders, robberies, rapes and other serious criminal cases. I have navigated complicated legal issues and I know how to handle both jury and non-jury trials. I have also guided many very vulnerable victims through the legal system in their search for justice. This has taught me that achieving justice requires more than just knowledge of the law; it requires compassion and empathy for people from all walks of life, which I believe I have in abundance.

As a judge, I must decide each case based on the law and the unique facts and circumstances of the individuals before me. In the juvenile justice system, the focus is on rehabilitation of the child who is the Respondent. This requires a holistic view of the case in deciding what is the just outcome, including not just the incident in question, but also the child and the child's life circumstances, including the child's background and life-challenges.

Diversion programs such as the Drug and Mental Health Courts in Montgomery County are excellent programs for providing the necessary services to many individuals who need these programs to be rehabilitated. In my experience as an Assistant State's Attorney, I recommended these programs for many individuals. Often times, these are the exact services that people need to put themselves on a better path forward. I am proud to work in a county that embraces these programs.

During the COVID crisis, many cases got put on hold, and as a result the system is still trying to resolve this backlog. Litigants should not have to wait as long as they do for such important cases as custody of a child to be heard, for example. In order to tackle this problem, we need more personnel, such as judges, clerks and interpreters, to name a few.

I litigated family law cases, including divorce, custody, child support, parentage, adoption, contracts, alimony, business and property issues, domestic violence and de facto parent. I was trained as a mediator and collaborative attorney and have a solid understanding of courtroom procedure and the rules of evidence derived from my practice. I spent over 16 years working in the areas of adoption and surrogacy and bring compassion, a calm temperament and passion for justice to the fore.

Due to Maryland Rule 18-104.4, I can't answer this question from a public policy perspective as Judges cannot make commitments regarding issues that may come before the court. Decisions are based on the individual facts and circumstances of each case. I understand that the overarching goal of juvenile court is rehabilitation and a judge must determine an appropriate result for each young person. It is beneficial to have as many options as possible.

Diversion programs are incredibly helpful to people who have mental health or substance abuse challenges and should be utilized when appropriate, based on the facts before the Court. Both the Mental Health and Drug Courts within our courthouse have made decisions that resulted in hundreds of successful outcomes for those who qualified for and embraced the opportunity provided through those diversion programs. These programs have saved lives and helped thousands of people.

The need for more resources is a challenge across the state and nationwide. The pandemic resulted in a delay in cases getting before a Judge, and the court is working hard to catch-up and meet the needs of litigants. We need more mediation and ADR options as well as attorneys to assist in pro bono programs. To leapfrog to where we want to be, the court is continually looking to hire qualified courtroom clerks, interpreters and other staff and to expand its programs that serve the community.

I have one of the most varied legal backgrounds of any judge in Maryland. I represented people in civil matters including contract disputes, easements, negligence and fraud cases, landlord-tenant disputes (residential and commercial), and defamation cases. I have tried nearly every type of criminal case from murder to traffic tickets. I have represented both mothers and fathers in custody and divorce matters. Most importantly, I have a calm demeanor to manage the big emotions of the courtroom.

It is important for judges to decide each case based on the individual facts and circumstances of that case and not be influenced by political or other considerations. Juvenile cases are no different. The goal of juvenile court is rehabilitation not punishment. For judges to fashion an appropriate and tailored rehabilitative outcome for each young person, it is beneficial to have as many options as possible including drug treatment, diversion, and mental health counseling.

Diversion programs are a miraculous benefit for people with behavioral and substance abuse issues. I served as the public defender's Drug Court representative for 3 years. That experience gave me the opportunity to have a small role in helping scores of people overcome their addiction and become productive members of our community. I am still in touch with some of them. It is humbling to see what they have accomplished. Drug Court Graduation is one of the most inspiring events at the courthouse.

One of the greatest challenges is a lack of resources. Despite closing more cases last year than were filed, the court still is backlogged from the pandemic. People need to wait too long for their cases to be heard. There needs to be more courtroom clerks, interpreters, judges, and other courthouse staff.

#### J. Bradford McCullough

I represented clients in complex high-stakes business litigation, and handled appeals in criminal cases, family law matters, and real estate cases. Working on such a wide range of cases prepared me well for the bench. I was also trained as a mediator and the circuit court frequently appointed me to help parties settle cases. That service helped me develop a fair and calm demeanor. I also served on nonprofits' boards of directors and provided pro bono representation to low-income clients.

That is a crucial policy issue for the legislative and executive branches. Candidates for election to a judicial office, however, are bound by Rule 18-104.4 of the Maryland Code of Judicial Conduct. We cannot make commitments, pledges, or promises regarding issues that are likely to come before the court. We must fairly consider each individual case that comes before us, on its own merit, without appearing to have prejudged any issue. But incarceration of juveniles must be a last resort

Diversion programs are wonderful tools that help individuals with substance abuse or mental health issues address those challenges, get their lives back on the right path, and minimize contact and involvement with the criminal justice system. Our court's programs have served those objectives and have literally saved lives. By helping folks become contributing members of society, those programs serve an important role for the individuals directly involved, as well as the entire community.

When the pandemic struck, courts had to close. That caused a tremendous backlog of cases that we are still trying to address. Mediation and other forms of alternative dispute resolution are always favored, as they help people solve their problems without time-consuming and expensive litigation. They are especially important tools now. The number of self-represented parties is also a challenge, which could begin to be addressed by increased participation by lawyers in pro bono activities.

## Judge, Appellate Court of Maryland At Large

(see Candidates below)

#### **Duties**

Judges of the Appellate Court of Maryland review the actions and decisions of the Circuit Court and Orphans' Court in cases brought before it. The Court, usually sitting in panels of three judges, decides if the trial judge followed the law and legal precedent. The Court is composed of 15 judges: eight at large and one each from seven appellate Judicial districts.

#### **How Elected**

When there is a vacancy on the Appellate Court, a nominating commission reviews the qualifications of applicants for the judgeship and recommends several names to the Governor. The Governor appoints a person from that list to fill the office, who must then be confirmed by the State Senate. After serving for one year, the judge is subject to approval or rejection by the voters at the next general election for a ten-year term (yes or no for continuance in office). If the judge is approved, the judge faces another "retention election" every ten years to continue in office. If the incumbent judge is rejected by the voters, the post becomes vacant, and the governor makes a new appointment.

#### **Term**

Ten years. No term limit. Mandatory retirement age of 70 years.

\$213,633 per year.

#### **Duties**

The Montgomery County Board of Education is responsible for the direction and operation of the Montgomery County Public Schools (MCPS). Board members' responsibilities include, but are not limited to, establishing and enforcing policies that govern MCPS, selecting and appointing the superintendent of schools, adopting operating and capital budgets, establishing curriculum guides and establishing school boundaries.

All voters, regardless of the district they live in or party affiliation, may vote for one At-Large candidate and one candidate each for Districts 2 and 4 this year.

As a parent of 2 young kids (8 & 9), PTA President, nonprofit leader, trained attorney, former Juvenile Public Defender, public servant and policy advocate whose educational journey began in Head Start preschool and progressed to law school via community college, I understand, firsthand, the MCPS community's challenges and how to navigate them. I employ efficient solution-oriented approaches to ensure equitable results and empower others.

To prepare our children to thrive, MCPS classrooms must reflect the world in which we live. In situations where parents deem material inappropriate, parents should have an opportunity to voice their concerns and may use the moment as an opportunity for family conversation with our children about the family's views and values.

Connection is key. MCPS must fulfill its commitment to hiring and providing schools with social workers and psychologists and provide them with the flexibility to support their students through methods that resonate with their student population rather than costly, cookie cutter curriculums. MCPS cannot be the sole solution provider for the externalities our students face and we must collaborate further with the County and community groups to include the provision of sufficient funding.

MCPS must meet students where they are and actively support their movement forward. School initiatives like WIN (What I Need) provide students with 30 min., 4x weekly, to group with similarly situated students and a teacher other than their assigned to work on concepts in which they struggle or receive enrichment in subjects where they excel. Teacher led tutoring for teacheridentified struggling students would also provide benefits.

MCPS asks a lot of its educators and compensation must match. Rising costs of living, especially in Montgomery County, necessitate increases in the MCPS budget if we want to provide our students—our future leaders—with the tools they need to thrive and lead via their educators. More resourcefulness and community collaboration in other budget areas may provide space for reallocation of existing funds to educator compensation but ultimately the budget must increase.

My service as a public school teacher prepares me best. I know the system from one of its most crucial points of success, which makes me qualified to speak from it. One of my undergraduate degrees is in political science. I am educated in this field and I can utilize my training as a member of the Board. I am prepared for this office not only because I am experienced as a teacher, but because I come with the experiences of a teacher. I know how to work hard because I work like a teacher.

MCPS should not allow opt-outs of these materials. Should a family wish to provide additional education to their child, they are welcome to do so at home or with their religious organization. As students mature, they will interact with people who may be different from themselves. MCPS's goal with these materials is to provide mirrors (to reflect back on students who see themselves) and windows (for students who do not see themselves to peer into someone else's experience and learn empathy).

Students who are in crisis are not able to learn, so MCPS must act. As a starting point, MCPS needs allocate more behavioral support personnel in each building. The nationally recommended ratios for school counselors (1:250), psychologists (1:500), and social workers (1:250) are not being met by MCPS. MCPS should also consider excusing students for 4 mental health days per year (approx. 1 per quarter) and enhancing the health curriculum from K-12 to include a greater mental health focus.

I would like to propose more implicit bias training for educators across MCPS as a starting point. We know that Black and Brown students are recommended for challenging courses at a lower rate than their White and Asian peers not because of scores, but due to implicit bias from educators. I also propose deeper examination of where resources are spent order to ensure that our most vulnerable students get what they need to thrive, along with more mentorship programs for students and staff.

Educators first deserve a living wage. The county council must fully fund the budget and then the Board must uphold the contract to pay teachers their salaries. Educators must also have a tenable workload. We must reduce the expectations placed on all workers in MCPS so we can retain educators in the system. MCPS already fosters mentorship through the Consulting Teacher program, but this should be expanded and extended to foster a supportive environment for MCPS educators.

My position is consistent with state law.

COVID caused school and classroom disruptions. Students faced depression, family conflict, anxiety, trauma, and more. As a board member, I fully supported the investments made in counseling and mental health services. The challenges for students remain. Together, the school system and our community at large must address these pressing issues.

As Board president, I supported and testified on the recommendations of the Commission on Innovation and Excellence in Education back in 2019. The legislation was passed as the Blueprint for Maryland's Future in 2021. The law ensures equitable outcomes for every student. The pillars are a focus of my work on the board and reflected in past and current budgets.

On the board, it has been important for Human Resources to strategically use the recruitment calendar, build relationships with colleges, and support staff that needs to work towards certification or hold conditional certifications. Offer a competitive salary to attract highly qualified and diverse teachers. Our "Grow Your Own" initiative can retain staff from within MCPS to become certified teachers.

I am a mom of two recent MCPS graduates and I have been in PTA and other children's advocacy leadership positions at the local, county, and state level for over a decade. I have been able to rebuild organizations after controversy and then develop productive relationships with decision makers at every level of government, leading to initiatives like the Safe School Drinking Water Act and funding for construction and wrap-around services. I'll be ready to achieve results from day one.

I am a founding member of the Coalition for Inclusive Schools and Communities, formed to support MCPS's position that there should not be an opt out policy for approved curriculum and books. We gathered over 3,000 signatures from Montgomery County stating that children should be able to see themselves and others in curricula. Allowing system-wide opt outs would lead to children leaving the classroom during science, language arts, and social studies, creating a chaotic classroom environment.

I support fostering more student connections to fellow classmates and trusted adults in schools. MCPS should implement intentional direct outreach programs for extracurricular activities, clubs, and lunch bunches. MCPS should also expand mental health services at school, providing more access to telehealth appointments and fully implementing Handle with Care. I have advocated for both initiatives at the state level. Parent support should also be offered through the parent academy.

Work to close the opportunity gap with comprehensive parent resources starting at birth. Universal Pre-K should be prioritized and funded, including offering scholarships for teacher training. Third grade literacy gaps should be a focus by using the science of reading, an early warning system, and intervention teams. In secondary school, equitable access to quality teachers should be ensured through incentives, in cooperation with the union. Close the tutoring gap by partnering with nonprofits.

First, we should implement and fund "Grow Your Own" initiatives. Fully fund the current program that enables MCPS employees to become teachers. We should grow our career program to train students to become effective teachers and then offer scholarships if graduates teach in their home district. We must also look at financial and benefit incentives to remain competitive with neighboring districts. Finally, evaluate exit interviews and ensure that MCPS has a positive growth mindset culture.



## **On the Ballot**Ballot Questions

Montgomery County voters are asked to mark their ballots FOR or AGAINST one amendment to the Maryland Constitution and one amendment to the Montgomery County Charter. The proposed changes are presented to voters as questions on their ballots. To be enacted, ballot questions require approval by a simple majority of the people voting on the question.

Ballot questions may be initiated in several ways through actions of the legislative body or by citizens. When the General Assembly proposes a change to the Maryland Constitution, it must place a referendum (a vote to approve or disapprove) on the ballot about the change. Citizens can also use a petition to place a ballot question to overturn or change a law passed by the General Assembly. This year the statewide ballot question is a proposed amendment to the Maryland Constitution.

In Montgomery County, the Montgomery County Council may propose changes to the county charter on its own or by accepting recommendations of its Charter Review Commission. Also, Montgomery County citizens have the right to use a petition to bring charter amendments to the county ballot. The Montgomery County charter amendment question is a result of a citizen petition.

Ballot questions summarize proposed changes to the Maryland Constitution and the Montgomery County Charter and will appear on the ballot just as they appear below. Voters often find it hard to understand the meaning of the amendments and whether to vote for or against each question.

ALL Montgomery County voters can vote for or against the State Constitutional Amendment and the Montgomery County Charter Amendment.

Vote **FOR** or **AGAINST** each question.

### Statewide Ballot Question – Constitutional Amendment

#### **Question 1**

Constitutional Amendment (Ch. 245 of the 2023 Legislative Session)

#### **Declaration of Rights – Right to Reproductive Freedom**

The proposed amendment confirms an individual's fundamental right to reproductive freedom, including but not limited to the ability to make and effectuate decisions to prevent, continue, or end the individual's pregnancy,

and provides the State may not, directly or indirectly, deny, burden, or abridge the right unless justified by a compelling State interest achieved by the least restrictive means. (Adding Article 48 to the Maryland Declaration of Rights.)

FOR the Constitutional Amendment

**AGAINST** the Constitutional Amendment

**Current Law:** Maryland law says that the State cannot stop a woman from ending a pregnancy before the fetus can survive outside the womb. A pregnancy also may be ended at any time if needed to protect the woman's life or health, or if the fetus has a serious medical problem. Doctors, nurse practitioners, midwives, and physician assistants can perform abortions. These providers are protected from being sued or charged if they perform an abortion in good faith. Health insurers and Maryland Medicaid must cover the cost of abortion services.

**Proposed Change:** The ballot question would not change existing law as stated above, but would add a new Article 48 in the Maryland Constitution:

"That every person, as a central component of an individual's rights to liberty and equality, has the fundamental right to reproductive freedom, including but not limited to the ability to make and effectuate decisions to prevent, continue, or end one's own pregnancy. The State may not, directly or indirectly, deny, burden, or abridge the right unless justified by a compelling State interest achieved by the least restrictive means."

The amendment is designed to protect the entire range of reproductive decisions including birth control, in vitro fertilization, fertility treatments and abortion.

**Origin of the ballot question:** This amendment was proposed by the Maryland General Assembly in Senate Bill 798 during the 2023 session. It was prompted by the U.S. Supreme Court's decision in Dobbs v. Jackson Women's Health Organization, which overturned Roe v. Wade. The Dobbs decision allows states to make their own abortion laws. Neighboring jurisdictions, like West Virginia, have banned abortion, while others, like the District of Columbia, protect the right to abortion.

#### **Arguments FOR the amendment:**

• Nearly 70% of Maryland residents disagree with the Dobbs decision, and almost 80% support a constitutional amendment to protect abortion rights in Maryland (Washington Post poll, September 2022).

- Because the Dobbs decision removed federal constitutional protection for reproductive freedom, a provision in the Maryland Constitution would be the strongest legal protection for this right in the state. Additionally, changing this constitutional provision would require approval by threefifths of the Maryland General Assembly and a majority of voters.
- Under this provision, abortions and other reproductive procedures would remain safe and legal in Maryland. In states where abortion is outlawed or restricted, the procedure will still take place but under potentially unsafe or deadly circumstances.

#### **Arguments AGAINST the amendment:**

- Maryland already allows abortion, so a constitutional amendment is not necessary. If passed, this amendment would restrict future legislators from making new abortion-related laws.
- The proposed amendment goes farther than existing law in that it would permit abortion at any time until birth without limitations.
- This amendment could lead to more abortions and could make Maryland a destination for out-of-state abortions.

A majority vote FOR Question 1 means the Maryland Constitution would affirm that everyone has the right to reproductive freedom, including the right to an abortion and that the state cannot limit this right unless justified by a compelling state interest achieved by the least restrictive means. Maryland's existing law regarding the right to an abortion would remain in effect but could be changed by the legislature if the change were consistent with this constitutional amendment.

A majority vote AGAINST Question 1 means the Constitution would not be changed. Maryland's current law about abortion would remain the same but could be changed by the legislature in the future.

#### **Question A**

**Charter Amendment by Petition** 

#### **County Executive-Term Limit – Reduction from Three to Two Consecutive Terms**

Amend Section 202 of the County Charter to decrease the term limit that applies to the County Executive from the current three consecutive terms to two consecutive terms.

The decreased limit would apply to anyone who already has served two consecutive terms as of December 2026.

FOR



**Current Law:** The County Executive is currently limited to three consecutive four-year terms.

**Proposed Change:** The proposed change would revise the text of Section 202 of the County Charter as follows:

#### Sec. 202. Election and Terms of Office.

The County Executive shall be elected by the qualified voters of the entire County at the same time as the Council and shall serve for a term of office commencing at noon on the first Monday of December next following the election, and ending at noon on the first Monday of December in the fourth year thereafter, or until a successor shall have been qualified. In no case shall a County Executive be permitted to serve more than **three two** consecutive terms. Any County Executive who will have served **three two** or more consecutive terms at noon on the first Monday of December **2018 2026** shall be prohibited from commencing to serve a successive term of office at that time. For purposes of this Section, service of a term includes complete service of a full term and partial service of a full term. Partial service of a full term means service by a County Executive of more than two years of a term.

**Origin of the ballot question:** A voter petition (signed by the required 10,000 registered Montgomery County voters) proposed this charter amendment.

#### **Arguments FOR the amendment:**

- Incumbents have an advantage in elections so a shorter term limit will provide more opportunities for fresh candidates with different perspectives to enter the race with a chance of winning.
- A two-term limit would match the two-term limits that apply to the U.S. President and Maryland's governor.
- Increased turnover for the office could make races more competitive and increase voter turnout. When voters think an election result is not in doubt, they may choose not to vote.

#### **Arguments AGAINST the amendment:**

- Voters already have the power to replace officials through the electoral process. The amendment would eliminate the voters' right to retain in office an executive they think is doing a good job.
- Partisan animosity against the current County Executive motivated the proposal; an unsuccessful candidate for County Executive led the group that submitted the petition.
- Of Maryland's 24 counties, 18 have either no term limits or a three-term limit for their County Executives.

**A majority vote FOR Question A** means the County Charter would be amended to reduce the term limit for the County Executive from three consecutive terms to two consecutive terms.

A majority vote AGAINST Question A means the County Charter would not be amended and the existing three-term limit would remain in effect.




